**RESCHEDULING OF THE BOARD LICENSURE EXAMINATIONS FOR
PROFESSIONAL TEACHERS (BLEPT), PHYSICIANS (BLEP) AND
SANITARY ENGINEERING (BLESE)**

WHEREAS, the Professional Regulation Commission (Commission) issued Resolution Nos. 2013-782 and 2013-787 fixing the dates and places of the professional licensure examinations for calendar year 2014, with the following schedules of the licensure examinations: Professional Teachers (BLEPT) on July 27, 2014; Physicians (BLEP) on August 16, 17, 23 and 24, 2014; and Sanitary Engineering (BLESE) on August 12, 13, and 14, 2014;

WHEREAS, the prescribed examination date for the BLEPT coincides with the historic anniversary celebration of the Iglesia ni Cristo (INC);

WHEREAS, July 27, 2014 has been declared as a special non-working holiday, under Joint Resolution No. 2014-12 of the Philippine Congress;

WHEREAS, an appeal has been brought to the Commission to reset the BLEPT schedule to give way to this commemorative event;

WHEREAS, there is a need to reschedule the BLEPT as well as other licensure examinations that will be affected by reason thereof, including the BLEP and BLESE, to ensure the smooth and orderly conduct of these licensure exams;

NOW THEREFORE, upon recommendation of the Professional Regulatory Boards for Professional Teachers, Medicine and Sanitary Engineering, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to reschedule the BLEPT to **August 17, 2014**, the BLEP to **August 23, 24, 30 and 31, 2014** and the BLESE to **August 26, 27 and 28, 2014**;

RESOLVED FURTHER, that the deadline for the filing of applications for the BLEPT is on **June 15, 2014** (for both Repeaters and First Timers), the BLEP on **August 1, 2014** and the BLESE on **August 6, 2014**;

RESOLVED FURTHERMORE, that the concerned Boards and other offices/divisions of the Commission undertake the necessary coordination and arrangements to effect the orderly administration of the licensure examinations involved;

For further dissemination, a copy hereof shall be posted in the PRC official website and distributed to the INC, the concerned professional organizations, the academe and other constituent offices/divisions of the Commission.
